# Notes on the 143<sup>rd</sup> National Encampment

The SUVCW and the Women's Relief Corps held their annual meetings August 2-4, 2024. Nearly 200 brothers were in attendance. Needless to say, there were many lengthy and pithy discussions on refinements to a variety of rules. Brother Don Gates of Camp 18 in our department rose to ask about a study on membership requirements that was done and reported since the previous encampment but which no one knew anything about. It was decided to form another committee, this time under Bro. Gates leadership, and give it another go.

The eleven brothers from Texas/Louisiana in attendance carefully observed the Encampment venue and proceedings in order to fine tune things for next year's adventure in Houston. They held a Zoom conference August 17 and their observations were extensive enough to cause a two hour meeting. I think it is safe to say that the planning committee has enough information to ensure a very successful Encampment next year.

I must single out Brother John Vander Meulen and his team from Camp 2 for a fine job of electronic ballet in getting John's audio visual recording equipment and the hotel's sound system to function together.

### 2024-2025 Commander-in-Chief Biography

From the National SUVCW Website



Commander-in-Chief Kevin L. Martin first joined the SUVCW in 1998 and became a life member in 2011. He was elected Commander-in-Chief at the 143rd Annual National Encampment at Lexington, KY on August 3, 2024.

At the camp level with Antietam Camp No. 3 in Frederick, Maryland, Commander-in-Chief Martin held the elective offices of Junior Vice Commander, Senior Vice Commander, and two separate terms as Commander. He has also fulfilled the role of Counselor of the Antietam

Auxiliary since 2015.

With the Department of the Chesapeake, he was elected Secretary/Treasurer for 3 years, Junior Vice Commander, Senior Vice Commander, Department Commander, and three times to the Department Council. Commander-in-Chief Martin was an integral member of the 2011 and 2015 National Encampment Host Committees, including co-design and production of the Encampment polo shirts. He also served as the 2015 Chief-of-Staff to Commander-in-Chief Tad Campbell.

At the national level, Commander-in-Chief Martin attended every National Encampment since 2008 (17 years), and served on numerous Encampment and Visitation Committees. He served three years as chair of the Standing Committee on Fraternal Relations, one year as chair of the Lincoln Memorial Centennial Committee, and as a chair of Program & Policy and Civil War Memorial Grant Fund committees. He served three years on the National Council of Administration, one year as Junior Vice Commander-in-Chief and then as Senior Vice Commander-in-Chief. Commander-in-Chief Martin is also a graduate of the SUVCW's Memorial University.

Commander-in-Chief Martin earned a B.A. degree in Information and Computer Science from Hood College in Frederick, Maryland. In 2024, Commander-in-Chief Martin retired as an IT professional for over 44 years with more than 27 years as a contractor for the Department of Defense (DoD) Defense Health Agency (DHA). He was born and raised in the town of Frederick, where he lives with his wife of over 36 years, Rosemary. Of special note, Rosemary currently serves as the National President, Auxiliary to Sons of Union Veterans of the Civil War (ASUVCW). They have a son, Tyler, who is also a member of the SUVCW.

Commander-in-Chief Martin honors his direct ancestor, Capt. Adam Benjamin Martin of the 6th Maryland Volunteer Infantry, Company H, who served under the Union banner and paid the ultimate price. Capt. Martin's brother, Sgt. Stephen G. Martin, served under his command and survived the war.

Commander-in-Chief Martin also belongs to the following organizations:

• The Maryland Society Sons of the American Revolution (SAR) since 1998

- Military Order of the Loyal Legion of the United States (MOLLUS) Life Member
- Sons of Veterans Reserve (SVR) Lt. Col., 2nd Military District Commander (retired)
- Member, Descendants of the Mexican War Veterans (DMWV) since 2008

## Camp 1 as Reported in the August "The Unionist"

#### Saturday, 10 Aug 2024 - Comfort, Texas

Department Camp Organizer Blair Rudy of *Col. Elmer Ellsworth Camp 18* of Dallas, was informed of the Commemoration Ceremony scheduled to take place at the *Treüe der Union Monument* in Comfort, Texas. He requested permission to represent the *SUVCW* at the event, and to make some appropriate remarks. He, in turn, put out the word to the Department. But since most of the more active members were just returning from the National Encampment in Kentucky, I was the only one available to attend the event in Comfort with Brother Rudy.

About forty non-SUVCW people did attend, with a wide variety of ages represented. A descendant of one of those buried under the monument conducted the ceremony and read the names of those killed in the incident (see following two stories).

I was gratified to see so many people from such a small town in attendance. This was an important event during the Civil War, yet I do not recall it ever being mentioned at any level in my schooling. It is fascinating to see that the war was not fought exclusively around the real or philosophical Mason-Dixon Line, but sometimes between neighbors far from active battle fronts.



I recently learned that many of the German immigrants lying under the stone had come to the Texas hinterland to escape political upheaval in the old country - upheaval due in no small part to a new philosophy promoted by a certain Karl Marx. The pro-Union militias in the Hill Country of Texas were not uniformly quiet political cliques gathering in the local bier keller - some were armed and engaged in occasional harassment of Confederate authorities. The apparent need to totally exterminate the Texas Unionists also seems to point out a strong component of hatred during the American Civil War.

Anyway, those are a few thoughts that rattled around in my head after the event. Those and the fact that I feel strongly that we need a stronger presence at this annual event in the future. Doing so clearly falls under our charge to tell the true story of the Civil War.

Memorial week I visited Mobile for a couple days. I went to see the Civil War sites but since I was there, I toured Battleship Alabama (BB60) in the harbor. Hard to miss it.



The History Museum of Mobile has artifacts from the CSS Alabama including a cannon. There are also some battle flags and weapons. The Semmes statue they took down from downtown Mobile is also in the museum.



I visited Blakeley State Park which has some of the best-preserved trenches and works from the Civil War. While Lee was surrendering, the biggest battle in AL was taking place. Capturing Ft Blakeley caused the Confederates to abandon Mobile. I also visited the old town site of Blakeley and saw the hanging tree.



Fort Morgan was the next on the agenda. Quite impressive and well preserved. I wandered all over the works. I ran into my old Pastor from WI outside of Morgan. It was a nice reunion.



I took the ferry across to Fort Gaines. Even better preserved than Morgan. There is a nice cannon ball dent in the inner wall of Gaines from a US Navy ship.



### **News from Around the Department**

From John C. Vander Meulen, Commander, Camp #2

#### Greetings All.

On Saturday, October 5, 2024, the Lieutenant Commander Edward Lea Camp will be conducting a graveside memorial ceremony to honor Captain Isaac Conroe, the founder of Conroe TX. It will take place at 11:00 a.m. at the Conroe family plot in the Glenwood cemetery in Houston. You, and the members of your respective Camps, are welcome to join us.

#### **Background**

Thanks to the research being conducted by Sue Berry, Daniel Pourreau, and others, we've discovered that Isaac Conroe served as a Sergeant in Captain Barker's Company, McClellan's Dragoons, Illinois Cavalry, protecting Gen McClellan from April to August 1861. He then mustered with Co. B 12th IL Cavalry Regiment, was promoted to 2nd Lieutenant of Company H in November 1862, then to First Lieutenant of Company A in March 1864, and then to Captain in March 1865. During the Civil War, Captain Conroe gallantly led his men at Antietam, Fredericksburg, and Gettysburg, three of the bloodiest and most decisive battles of the War. He was injured at Gettysburg with bullet to neck/ mouth, losing a few teeth. He mustered out in Houston, TX, in May 1866 making his service in the War one of the longest and most distinguished of anyone who served. Isaac was also a founding member of McClellan Post 9 of the Grand Army of the Republic.

#### **Attendees**

Noteworthy attendees include living descendants of Isaac Conroe and the Mayor *Pro Tem* of Conroe, Texas. Approval of a Mayoral Proclamation is pending. Invitations have also been sent to both the Montgomery County and Harris County Historical Societies as well as print and TV news outlets.

Other member organizations of the Allied Orders expected to attend include the (a) the Auxiliary to the Edward Lea Camp, (b) the Sarah Emme Edmonds Detached Tent #1, Daughters of Union Veterans of the Civil War (DUVCW), and the Military Order of the Loyal Legion of the United States (MOLLUS).

This ceremony will follow the G.A.R. ritual protocols. It event is going to be a big deal!
